1. Grand total fee paid upfront is not recurring.
2. The only recurring fee is the annual fee (Due on July each year).
3. The pro-rated fee is the partial annual fee based on the join month till June.
4. The Security Deposit is the equivalent of one year's annual fee, and it will be :
 - i. used to offset the GS1 Malaysia Berhad subscriber's annual fees if the payments are in arrears for a period of three months after the date of invoice.
 - ii. be refunded upon confirmation of termination, if not already used to offset the annual fee.
5. Category B is not available to Limited (Berhad) or Private Limited (Sdn Bhd) companies.
6. A Category B application is subjected to review by GS1 Malaysia Berhad.
